I intend this RELEASE OF LIABILITY to be effective whether or not any loss, damage, injury or death RESULTS FROM THE NEGLIGENCE of the Owners. I understand that negligence means a failure to do an act which a reasonably careful person would do, or the doing of an act which a reasonably careful person would not do, under the same or similar circumstances to protect him or herself, or others, from accident, injury or death. I understand that the contracted service provider of the Activity, who is not affiliated with the Owners in any way or form, offers professional services to the public community, but it is my own responsibility to ascertain his credentials and certifications prior to engaging myself or my dog(s) in the Activity. I will follow the advice of and use the services of this service provider at my own risk.

I agree to be solely responsible for my own safety and that of my dog(s) and to take every precaution to provide for my own safety and well-being, and that of my dog(s) while participating in activities sponsored or conducted by the Club, including inspecting all situations, equipment and make my own assessment as to whether it is safe and free from all defects. This RELEASE AND WAIVER is given in the interest of permitting the Club to hold the event at the Property and to enable my fellow club members, the Owners, and me to feel free to attend this Activity without fear of liability. I further understand that there is no insurance coverage for the Club for this event and that I am expected by the Club to have appropriate medical insurance in full force and effect. I understand that any claim for coverage of medical bills will be submitted to my own insurance company.
